

DEALER FIVE-YEAR STEP-SAVER® MANUAL COVER SYSTEM WARRANTY

- 1. **SCOPE OF COVERAGE:** This warranty applies to the new STEP-SAVER manual cover system as a whole, including all of its components and parts when purchased by a retail buyer. Except as provided by applicable law, this limited warranty does not cover any incidental or consequential damages.
- 2. **7-YEAR WARRANTY ON COMPONENTS:** Cover-Pools Incorporated warrants the STEP-SAVER manual cover system to be free from defects in material and workmanship, or failure to perform, under normal use and service for seven (7) years at the completion of installation to the original purchaser, transferable to subsequent owners. Subsequent owners are required to provide notice to Cover-Pools Incorporated, by registering name and address within thirty (30) days of purchase date. This warranty does not cover any labor after the first year.
- 3. 5-YEAR LIMITED PREMIUM FABRIC WARRANTY: Cover-Pools Incorporated warrants the STEP-SAVER manual cover fabric to be free of material defects under normal use and service for five (5) years as hereinafter provided. The cover fabric will not shrink or deteriorate as to its imperviousness to water to such an extent that water cannot penetrate the cover in such quantity as to make the cover no longer reasonably operable. The vinyl is not warranted against the occurrence of minor pinholes. The vinyl or webbing is not warranted against fading. In the first two (2) years of the warranty period Cover-Pools Incorporated will repair or replace the defective cover without charge for material. During the third through fifth (5) year of the warranty period, the costs of repair or replacement will be prorated at 1/60 per month for each remaining month of the warranty. This warranty does not cover any labor after the first year.
- 4. **WARRANTY PERFORMANCE**: Service will be provided by your local distributor during normal business hours after you notify the dealer, giving identification of the equipment, date of completion of installation, and nature of defect(s). To verify your warranty is still in effect, you must furnish proof of purchase. For the location of the nearest authorized Cover-Pools Incorporated service facility, call or write Cover-Pools Incorporated Customer Service Representative.
- 5. **WHAT IS NOT COVERED:** This Limited Warranty does not cover any condition or damage which, in whole or in part, results from or is caused by any abuse, neglect, normal wear and tear, or improper use, maintenance, or operation, including your failure to comply with the printed owner's manual furnished with STEP-SAVER manual cover system. To illustrate, but without limitation, this warranty does not cover or apply to:
 - a. Any condition resulting from a defect in or use of a component part which is not part of the STEP-SAVER pool cover system.
 - b. Any condition resulting from failure to provide maintenance, cleaning, and repair in accordance with the printed Owner's Manual.
 - c. Any condition or damage resulting from any misuse, abuse, neglect, accident, alteration, or failure to secure or maintain.
 - d. Normal fading and minor deterioration of exterior surfaces resulting from exposure to the elements.
 - e. Powder-coated or custom coloring on extrusions, except that the coloring will have a limited three (3) year warranty per conditions set forth in this warranty.
 - f. The water removal pump (the pump is warranted by its own manufacturer).
 - g. Any condition resulting from installation practices inconsistent with applicable building and electrical codes or Cover Pools Inc installation instructions.

6. OTHER RIGHTS AND REMEDIES:

- a. No other Express Warranties. Unless otherwise explicitly agreed in writing, it is understood that these are the only written warranties given by Cover-Pools Incorporated. Cover-Pools Incorporated neither assumes nor authorizes anyone to assume for it any other obligations or liability in connection with this system.
- b. No Implied Warranties. There are no representations, agreements, obligations or conditions, express or implied, statutory or otherwise, relating to this warranty by Cover-Pools Incorporated, other than herein expressly contained. This express warranty excludes any and all implied warranties, including any implied warranty of merchantability or implied warranty of fitness for a particular purpose. There are no warranties, which extend beyond the description on the face hereof.
- c. Arbitration. Any dispute between the buyer and Cover-Pools Incorporated pertaining to this warranty shall be resolved by arbitration according to the rules of the American Arbitration Association.
